Senior Dining Centers are located in every county and 23/d tribe, totaling approximately 600 statewide. Hot, nutritious meals are usually served around the noon hour.

Call the local nutrition program for reservations.

(24 hours/1 business day advance notice is required by most programs.)

Each nutrition program also offers Home-Delivered Meals to 60+ adults who meet the eligibility criteria. Call the Aging Unit for more information. Programs listed as "Independent Programs" are likely fee for service. They are included in this document as an option as they may provide meals on additional days and special diets.

Older Americans Act-Funded Nutrition Program

The purpose of the elderly nutrition program is:

- To reduce hunger and food insecurity.
- To promote socialization of older individuals.
- To promote the health and well-being of older individuals by assisting such individuals to gain access to nutrition and other disease prevention and health promotion services to delay the onset of adverse health conditions resulting from poor nutritional health or sedentary behavior.

Objectives of the Program

The objectives of the elderly nutrition programs are to:

- Prevent malnutrition and promote good health behaviors through nutrition education, nutrition screening, and intervention of participants.
- Serve wholesome, delicious meals that are safe and of good quality, through the promotion and maintenance of high food safety and sanitation standards.
- Promote or maintain coordination with nutrition-related and other supportive services for older individuals.
- Target older adults who have the greatest economic or social need with particular attention to low-income minority and rural individuals.

History of Program

The Older Americans Act (Public Law 89-73) was enacted in 1965 to provide assistance in the development of new or improved programs, which help older persons. One of the first programs established through the Act was the elderly nutrition program. Listed below are a few milestones of the program.

- In 1968 Congress appropriated two million dollars for the establishment of a three-year demonstration and research program of nutrition for older people, to be conducted by the Administration on Aging (AoA) under Title IV of the Older Americans Act (OAA).
- Congress enacted the National Nutrition Program for the Elderly in 1972 as a new title of the OAA (P.L. 92-258, S. 1163, sponsored by the honorable Edward M. Kennedy, democrat, Massachusetts), signed by President Nixon on March 22, 1972.
- Pilot elderly nutrition programs began serving congregate meals in Wisconsin in 1972, with the majority of areas being served by 1974. The first home-delivered meals were served in 1978.
